Product Organic Ginger Crystallised 5 kg

Code 100552

Description Hand trimmed stem ginger rhizomes (Zingiber officinale), cut to size and shape, dusted in castor sugar Prepared from sound, fresh, young stem ginger. Visually inspected washed to remove foreign matter. Cut to size and shape, preserved in heavy brine& citric acid. Flushed in running water to reduce salt to specified levels. Cooked @>100°C and stabilized in syrup of brix 68-74. Drained and baked in oven to crystallize. Dusted with sugar. 2nd sorting on light table. Passed through 2 magnet bars (1000GS), First Metal detection (Fe 1.0mm, SUS 1.0mm), Packed, Metal detected (1.5mm Fe/3.0 Non-Fe /2.5mm Stainless Steel), weighed and stored at ambient. Citric acid is used as a processing aid to adjust the pH and negligible amounts are carried over into the final product

Taste Typical of crystallised stem ginger, spicy, sweet, with some citrus top notes. No off flavours or taints.

Texture Firm, with a crisp bite, not woody or fibrous (physical fibre max 10%)

Colour Even, golden yellow

Ingredients in descending order of weight Organic Crystallised Ginger (91%)
Organic Sugar (9%)
Note the sugar country of origin is Brazil / Paraguay

Packaging 5kg food grade cartons with food grade blotter board on top. No staples used. Cartons sealed with adhesive tape and placed in clear poly bags which are then heat-sealed. 4 poly bags then packed into cardboard carton outers and sealed with adhesive tape
